PLACEMENT DETAILS

What Cooperative Partners Receive

Agent Portal Dashboard	Your brand appears in the agent-facing dashboard - the interface agents return to every time they log in to manage verifications and track their portfolio. The highest-frequency touchpoint in the entire platform.
New Agent Onboarding Sequence	Every agent who joins moves through a structured onboarding email sequence. Cooperative Partners are featured as vetted recommendations - at the moment when agents are most actively evaluating tools and services for their practice.
Partners Page Listing	A dedicated cooperative endorsement on the ITZA Vault Partners page, including your logo, a description of your business, and a direct link. Framed as a cooperative recommendation, not advertising.
Quarterly Insights Article	One sponsored article per quarter in the ITZA Vault Insights section, written with or by your team on a topic genuinely useful to agents. Editorial-style placement, not display advertising.
Monthly Agent Communications	Inclusion in the cooperative's regular communications to its agent network. Agents read these because they contain information directly relevant to their practice and earnings.



RATE ESCALATOR

Rates Rise With the Network - Lock In Now

Partnership rates are published transparently against agent network milestones. Partners who sign at the current milestone lock their rate for the full contract term. As the network grows and the audience value increases, rates adjust at each threshold. The earlier you join, the better the economics.

The row highlighted above reflects the current rate band. Partners who commit now lock this rate for their full contract term.

FOUNDING SPONSOR PROGRAM

Permanent Economics for Early Partners

A small number of founding sponsor positions are available across select categories. Founding sponsors commit while the network is still building and in return lock in 60% of the current Cooperative Partner rate permanently - for the life of their relationship with the cooperative.

- Founding rate locked permanently regardless of future rate escalations
- Founding Sponsor designation on the Partners page - visible to all agents
- Maximum ten founding sponsors across all categories combined
- One founding position per category maximum
- Commitment required within the founding window - positions close when filled

OPEN CATEGORIES

Available Partnership Categories

Partnership is limited to businesses that genuinely serve the professional needs of notaries and legal professionals. Categories are reviewed before any partner is accepted.

Category	Description
Notary Supplies and Equipment	Stamps, seals, journals, embossers, professional supplies
Professional Liability and E&O; Insurance	Errors and omissions, notary bonds, professional protection
Business Banking and Finance	Business accounts, banking, financial products for self-employed
Accounting and Invoicing Software	Bookkeeping, invoicing, tax tools for independent professionals
Scheduling and Appointment Tools	Booking, calendar management, client scheduling platforms
Continuing Education and Certification	State-approved CE courses, notary training, professional development
Legal Practice Management Software	Case management, document tools, practice software
Notary Bonding	State-required surety bonds and bonding services

NEXT STEPS

How to Become an ITZA Vault Cooperative Partner

1. Confirm category availability	Contact us to check that your preferred category and tier are still open. Categories with three national partners are closed to new entrants at that level.
2. Select your tier and region	Choose between Cooperative Partner (national), Regional Partner, or Directory Partner based on your audience footprint and budget. Founding sponsor positions are handled separately.
3. Review and sign the partner agreement	We send a straightforward partner agreement covering placement, rate, term, and the cooperative endorsement framework. Minimum initial term is three months for Regional and Directory tiers, six months for Cooperative Partner tier.
4. Go live	Placements are activated within five business days of agreement. Portal and email placements begin with the next agent communications cycle. Partners page listing goes live immediately.
